NOTICE OF CHANGED TRAFFIC CONDITIONS Bruxner Way, Tenterfield

In accordance with Section 115 of the Roads Act 1993, notice is hereby given by Tenterfield Shire Council as the Roads Authority that changed traffic conditions will apply to Bruxner Way, between the New England Highway and Sunnyside Loop Road, Tenterfield.

It is anticipated that the works will commence mid March 2020 and will take up to 3 months to complete, weather permitting. Works will be undertaken between the hours of 6.30am and 6pm and may involve weekends.

The works will involve Council and its contractors utilising plant and machinery for the duration of the works including road widening and rehabilitation.

Motorists and pedestrians may experience delays of up to 15 minutes and are requested to pay particular attention to the advance warning signposting and directions of on-site traffic controllers.

All heavy traffic is encouraged to use an alternate route such as Sunnyside Platform Road to access the New England Highway.

TEMPORARY CHANGES TO CUSTOMER SERVICES DURING RENOVATIONS

In 2019 Council applied for, and was successful in obtaining grant funding to upgrade the Council Chamber to become a dual purpose Emergency Centre/Council Chamber. Contracts have been let and these building and renovation works are due to begin.

Tenterfield Shire Council wishes to advise residents that from Monday, 9 March 2020, Customer Services will be temporarily located at the Visitor Information Centre at 157 Rouse Street, Tenterfield. This is due to renovation works being carried out at Council's main Administration building, located at 247 Rouse Street, Tenterfield.

There will be no public access to Council's Administration building from Monday 9 March 2020 until completion of the renovations to the Customer Services area at the front of the building.

Council anticipates that this will be approximately 8 weeks.

During this period, residents will be able to make payments, request appointments for Planning & Development services and lodge enquiries at the Visitor Information Centre. Council encourages residents to call (02) 6736 6000 if they wish to speak to a specific service or person. As always, residents can make payments at any time via BPAY, direct debit or credit card. RESTRICTION OF WATER SERVICES FOR UNPAID ACCOUNTS

Water & Sewerage Notices were due for payment on 1 February 2020. Multiple reminder notices have been issued by post and hand delivered to properties.

If full payment of water & sewerage accounts have not been made or a satisfactory arrangement entered into, Council will install a water flow limiter. Limiter installations are scheduled for Monday 16 March 2020. Additional fees will be incurred if a water limiter is installed.

Ratepayers are reminded that interest now accrues on all overdue water & sewerage consumption charges on a daily basis at a rate of 7.5% per annum.

RATES & CHARGES THIRD INSTALMENT DUE FOR PAYMENT

Council wishes to advise Resident's and Business Owners that the Third Rates Instalment Notices were issued on 22 January 2020. These accounts were due for payment on 28 February 2020.

LEVEL 1 WATER RESTRICTIONS INTRODUCED FOR TENTERFIELD

Tenterfield residents are advised that as from 9.00 am Monday, 2 March 2020, Level 1 Water Restrictions will be introduced.

Residential Properties:

- Use of fixed hoses, sprinklers, micro sprays/garden watering systems limited to 2 hours per day;

Public/Commercial Properties:

- Public gardens, sports grounds, show ground and nurseries sprinklers are limited to 2 hours per day and Market garden sprinklers limited to 6 hours per day;

There are no other restrictions in place.

REMOVAL OF WATER RESTRICTIONS FOR URBENVILLE

With water now overtopping the weir at Tooloom Falls and more rain forecast, water restrictions for Urbenville, Woodenbong and Mulli Mulli were lifted, Monday, 24 February 2020.

In line with Council's current Drought Management Plan, Mayor Peter Petty, Deputy Mayor Greg Sauer and several members of the Executive Team took the decision to remove water restrictions for the Urbenville area from 4.30 pm.

Council will consider the Drought Management Plan in the months to come and may consider reintroduction of low level water restrictions to keep the value of water front and centre with our community.

"We have all learnt a lot during this severe drought and Council and the community need to ensure that supply of potable water is not taken for granted", said Mayor Peter Petty.

"Our communities can be assured that Council are taking these lessons learnt and continuing works to make sure we are water fit into the future", the Mayor added.

Recently, Council applied for emergency relief funding of \$1.9 million to secure additional raw water for Urbenville with the following scope of works:

- Identification of an appropriate ground water source;
- Installation of appropriate water extraction and delivery infrastructure; and
- Provision of a 50 ML off-stream storage (Tooloom Creek).
- Ground water sourcing would include water search, drilling and water quality testing and installation of infrastructure being pipework, electrical and bore head components.

"Unfortunately we have been unsuccessful in this application, however that will not deter our staff from examining every opportunity for funding to ensure that Urbenville, Woodenbong and Muli Muli communities are guaranteed an adequate, potable, water supply into the future as we face unknown climatic change", Mayor Petty concluded.

JENNINGS WATER RESTRICTIONS EASED TO CRITICAL LEVEL

Southern Downs Regional Council advise that as from Monday, 24 February 2020, water restrictions have moved from Emergency Level to Critical Level of 100 litres per person per day.

Jennings residents are urged to remain vigilant with water usage as the rain event did not fill water catchments with water continuing to be trucked from Warwick to Stanthorpe.
