# Council Media Release: 6 April 2020 Review of Council's Drought Management Plan

Due to the severe drought conditions, Tenterfield and Urbenville water reticulation areas had water restrictions imposed for 22 months – April 2018 to March 2020 which not only impacted the townships, but once Level 4.7 was reached, had severe repercussions on the rural community as well.

The Plan was implemented in 2010 following the dry conditions of 2009. However, actioning of the Drought Management Plan in April 2018 was the first time the measures of the Plan had been enacted and many lessons were learnt as a result of these harsher and drier times.

In order to ensure this knowledge is captured, Council is now reviewing the Drought Management Plan. Feedback is sought from the community and businesses about how Council can improve our response to future droughts.

# Council Media Release: 6 April 2020 Warning to Easter Campers

Police will have the power to issue \$1,000 on-the-spot fines for individuals and \$5,000 for corporations not complying with Ministerial directions relating to COVID-19 as part of a State-wide crackdown on reckless behaviour to slow the spread of the virus.

Officers will also no longer require a warrant to arrest an individual breaching a public health order, after the NSW Government passed legislation to give Police greater powers to enforce orders under the Public Health Act 2010.

With beautiful autumn weather predicted for the Easter break, Council is warning those who are planning to come to Tenterfield Shire area to camp on the banks of the Clarence River and elsewhere, that the Stay at Home Rules issued by NSW Health apply.

Council has advised Police of the high risk areas and it is anticipated these areas will be patrolled throughout the Easter break and beyond.

"Despite the majority of people doing the right thing, there are those who are still behaving recklessly and irresponsibly, endangering the lives of others, particularly the elderly and immunocompromised members of the community", said Mayor Peter Petty.

"I am aware that Easter is a time when families get together to camp in our beautiful remote areas, however this is not the year to do it. Please stay home and respect the wellbeing of others", Mayor Petty urged.

## Message from New South Wales National Parks & Wildlife Service: Exercising in a NSW national park during COVID-19

NSW National Parks and Wildlife Service (NPWS) is working to keep your local national parks open during the COVID-19 pandemic, but as NSW national parks have experienced significant increases in visitors in recent weeks, particularly during weekends, we need your help.

Although we have had to close some facilities, including campgrounds and high-visitation areas (beaches, picnic facilities, busy lookouts) to protect staff and the community, many walking tracks remain open for exercise and we want to keep them that way. **We ask that you please comply with the following directives and health measures:** 

- In line with the advice of government and health authorities, you are advised to cancel all holiday travel plans to NSW national parks.
- If your planned visit to a NSW national park is for a purpose other than exercise, you should reconsider your plan as you may be in breach of the <u>current public health orders</u>.
- If you wish to exercise in a national park, choose a park close to your home. Visitors are reminded that <u>non-essential travel is currently not permitted</u>.
- If you are unwell, stay at home.
- Practice social distancing.
- If you arrive at a national park or other public space and it is too crowded to practice social distancing, it is your responsibility to leave the area. Please do not wait to be instructed by NPWS or police.

NPWS officers and NSW Police are patrolling national parks to ensure visitors are complying with social distancing measures and other public health orders.

If visitors do not comply with these public health requirements, NPWS may need to close more areas of national parks. If an area closes, it is unlikely we will be able to reopen it until the public health guidelines change.

So please enjoy our NSW national parks, but be sure to exercise care while exercising your body, so we can keep these incredible places open.

# \$10,000 Grant Assistance Scheme for Small Business

Thousands of small businesses across NSW struggling to cope with the COVID-19 shutdown will receive grants of up to \$10,000 under a new assistance scheme. Many local cafés, restaurants, corner shops, gyms and small accommodation providers will be eligible to apply. Applications for a small business grant of up to \$10,000 will be available through Service NSW within a fortnight and remain open until 1 June 2020.

To be eligible, businesses will need to:

- Have between 1-19 employees and a turnover of more than \$75,000;
- A payroll below the NSW Government 2019-20 payroll tax threshold of \$900,000;
- Have an Australian Business Number as at 1 March 2020, be based in NSW and employ staff as at 1 March 2020;
- Be highly impacted by the Public Health (COVID-19 Restrictions on Gathering and Movement) Order 2020 issued on 30 March 2020;
- Use the funding for unavoidable business costs such as utilities, overheads, legal costs and financial advice;
- Provide appropriate documentation upon application.

#### Australia Council Announces New Resilience Fund for Arts

A new \$5 million Resilience Fund for artists and arts organisations will open for applications today, offering welcome support to the nation's arts and cultural sector, which has been hard hit by the COVID-19 crisis. The Australia Council, the Australian Government's arts funding and advisory body, announced the Resilience Fund this week to address the immediate and enormous challenges the sector is currently experiencing. The fund will provide immediate relief to Australian artists, arts workers and arts organisations to support their livelihoods, practice and operations.

# The 2020 Resilience Fund includes three streams:

- Survive small grants for individuals, groups and organisations to offset or recoup financial losses due to cancelled activity
- Adapt grants for individuals, groups and organisations to adapt their practice and explore new operating models
- Create grants for individuals, groups and organisations to continue to create artistic work and develop creative responses in a time of disruption

Organisations that currently receive multi-year funding from the Australia Council are not eligible to apply. Artists and organisations that have existing agreements with the Australia Council are encouraged to contact their contract manager to discuss flexible support options at this time.
