

LGNSW's Water Management Conference is a major annual event that provides a dedicated forum to discuss water policy initiatives and trends, hear about the latest technical issues and share best practice in urban water governance and management.

The 2020 conference will be co-hosted by Narrabri Shire Council and it is anticipated that more than 200 delegates from NSW and interstate will attend, including councillors and council general managers, water utility managers, professionals, policy makers, researchers and other key industry stakeholders.

Delegates will have the opportunity to find out about the latest water policy initiatives and trends, receive updates on emerging technical issues, establish benchmarks and take advantage of networking, professional development and team building sessions.

In recognition of the in-person event that was originally scheduled to be held in July, there will be a webinar on Thursday 16 July 2020 with special guest speaker the Hon. Melinda Pavey MP, Minister for Water, Property and Housing. It will focus on COVID-19 recovery and regional solutions, as well as resilience with investing in water utility. In addition, there will be a Q&A session where the audience can ask the Minister questions.

# Compelling reasons to travel to Narrabri

A leader in water ingenuity for rural areas, Narrabri Shire is also home to a diverse range of beautiful natural resources and wildlife, and a dynamic and engaged community. It is an agricultural wonderland and renowned for the production of some of the world's highest quality wheat, cotton, fat lambs and beef. It is also a bustling town offering a wonderful selection of shopping, restaurants, attractions and museums.

The Narrabri region is famously known as "Big Sky" country because of its captivating star-filled night skies. It is home to natural wonders such as the Sawn Rocks, Pilliga hot artesian bore bath and the Salt Caves. With a mix of country charm and soul, Narrabri is an inviting gateway to stunning nature views and the picturesque setting of Mt Kaputar National Park.

Just you, five million stars, a mountain range and a yowie is another compelling reason to attend this year and find out what "Destination Narrabri" means for the business and leisure traveller. The Pilliga Forest, with its vast and unusual semi-arid woodlands spanning over 3000sq km, is said to be the home of this Big Foot kin. Seekers are drawn from across the globe in search of this mystical creature.

#### Conference Program

Over recent years, NSW councils and local water utilities (LWUs) have confronted several complex and unprecedented challenges in providing safe water to their communities. Although recent rain has restored coastal dam levels, many inland towns continue to face the prospect of "day zero" - when water supplies dry up. Meanwhile, the devastating bushfires have exposed water supplies and catchments to the risk of contamination, potentially compromising existing, dwindling water supplies.

The 2020 LGNSW Water Management Conference will feature case studies and learnings from these experiences, focusing on building preparedness, capacity and resilience.

Program highlights include:

- overcoming the "yuck factor" the case for purified, recycled water as a drinking water source;
- understanding the impacts of extreme weather events on water quality;
- learning about innovative and scalable water treatment technologies; and exploring indigenous water management practices.

#### **Site Visits**

#### Water storage treatment site

In Narrabri, attendees will visit the 11.4 ML Narrabri Water supply storages and pump station, which are key components of infrastructure of the Narrabri Water Augmentation Project. Both offer insight into projects undertaken by the council to improve water use and water services in recent times.



The Narrabri Water Augmentation Project will secure the township's water supply for the next 25 years. Although its water supply already meets the Australian Drinking Water Standards, the quality of Narrabri's drinking water has long been a contentious issue. This \$14.18 million project will centralise storage, enabling more efficient processing and distribution and bringing water treatment one step closer.

Construction is expected to be completed in June 2020, with the decision to treat water to a higher level to be determined following community consultation and future funding opportunities.

#### Baan Baa Water Supply Project

Baan Baa village has great opportunity for growth, with nearby coal mines and a healthy agricultural sector, but has had no secure water supply since its establishment in 1882. The Baan Baa water supply project was a drinking water supply scheme that began in early 2017. The total budget for the project was \$4,46 million, yet it was completed for \$3.28 million.

Works included a solar panel system to reduce long-term operational costs and an automated remote meter reading system. This was essentially a greenfield site that had many technical issues to overcome and other services to work around, such as telecommunications, low and high voltage power, the rail system and existing road networks.

Baan Baa now has a secure source of water. The project provides the region with a secure, sustainable and efficient water supply for the generations ahead.
