providers. Rural addressing numbers are based on a distance from the starting point - usually a road intersection – with odd numbers on the left and even numbers on the right.

A Rural Address issued to your property is the authoritative, compliant and recognised address for that property. Farm names, Lot numbers and post office RNB numbers are just a few ways people identify their property to other people. These are not considered to be compliant addresses under the NSW Addressing User Manual and can cause delays and inconvenience for emergency services and the delivery of goods and services to the rural community.

To assist rural property owners, Council has available rural address posts for purchase. An application form must be completed and council staff will erect a yellow post with your unique property number at the access to your property.

If you do not have a Rural Address Number please refer to Council's website for further information on how to apply for one or contact Council's Engineering Officer on (02) 6736 6026.

DEAD TREE REMOVAL PROGRAM TENTERFIELD RU 5 AREA

Council, at the Ordinary Council Meeting held Wednesday, 24 June 2020, resolved that quotations be sought for the removal of 155 trees out of the 1,034 Expressions of Interest (EoI) received by Council for the Dead Tree Removal Program, Tenterfield RU5 area.

"Grant funding of \$85,000 provided under the *National Bushfire Recovery Grant* meant that not all EoI's were successful", Mayor Peter Petty said.

"Councillors and staff carefully considered all applications with the trees nominated for removal meeting the following criteria:

- Within a bushfire prone area;
- Height of the tree; and
- Risk Factors.

Council will now proceed to seek quotations for removal of the selected trees and determine a contractor. Once awarded the project, the contractor will liaise directly with the owners of the selected trees to arrange removal and disposal leaving the stump (and in some instances the felled trees) as advised by the owners', Mayor Petty added.

Quotations will be evaluated and should the budget is exhausted prior to the full list of 155 trees being completed or if there is additional budget allocated, the next tree on the list will be added or removed as required, until such time that all monies have been spent.

Applicants who have registered their interest for the Dead Tree Removal Program will receive correspondence from Council by August 2020, confirming the status of their tree/s.

WORKS ON THE WATER! Tenterfield's New Aeration System

Council's Staff in conjunction with DPIE have investigated, designed and are nearing installation of a new aeration system to aid in the pre-treatment of the raw water in the dam.

The aeration system introduces additional air near the dam wall intake structures to aid in delivering a consistent quality of water which assists in the processing to provide potable water to residents. The aerator will reduce the episodes of dam turnover (mixing of bottom layers), a natural occurrence for closed water bodies where the depth of the water columns are defined by thermoclines which as you go from the surface of the dam to the bottom different layers with different temperatures, oxygen levels and turbidity appear as stratification (or layering).

Residents will notice over the coming weeks a floating platform in the dam which is required to lay the large pipe and anchoring system for the aerator. Works for the aerator was disrupted by COVID19 delaying the arrival of a large claw blower which waited on docks in Italy for over 4 months.

There are many rural properties where property numbers are absent from property entrances and are not visible from the road or cannot be seen at night. This can cause significant delays for emergency services (eg. fire, ambulance, police) and the delivery of goods and services to the rural community.

Rural addressing is a collaborative community project administered by Land and Property Information (LPI, a division of the NSW Government Office of Finance and Services) and local councils, and is supported by all emergency services, Australia Post and other service
