Rates have been increased in line with the rate peg of 2.6% as determined by the Independent Pricing and Regulatory Tribunal (IPART) and a revaluation of properties has been issued by the Valuer General to take effect from 1 July 2020. Council resolved at the 26 February 2020 Ordinary Council Meeting that a one off rate rebate of \$100 per rates assessment be applied, this has been allocated to the 1st instalment. This rebate was funded from a \$500k grant provided by the Federal Government's National Bushfire Recovery Agency.

Please be advised that Council has allocated three (3) waste vouchers per rate assessment for this financial year (1 July 2020 to 31 July 2021). Vouchers will not be replaced if lost or destroyed. Regular audits of redeemed vouchers are performed and in the event excess vouchers have been used for a single assessment an invoice will be issued.

The Office of Local Government has set the interest rate payable on overdue rates and charges and water & sewerage consumption accounts for the 2020/2021 at 0% for the period 01/07/2020 to 31/12/2020 and 7% p.a. for the period 01/01/2021 to 30/06/2021.

Message from the Minister for Customer Service Victor Dominello, NSW Government

COVID-19 RESTRICTIONS TAKE EFFECT

NSW businesses are on notice to comply with the State's public health orders, or risk a fine or closure, with restrictions around "higher risk" activities coming into effect.

From 24 July 2020 the following rules are in force:

Compliance measures introduced to pubs will be extended to restaurants, bars cafés and clubs. This includes:

- Limiting group bookings to a maximum of 10 people;
- Mandatory COVID-Safe plans and registration as a COVID-Safe business;
- A digital record must be created within 24 hours.

Weddings and corporate events are limited to 150 people subject to the four square metre rule and registration of the venue as a COVID-Safe business. Strict COVID-Safe plans must be in place and high-risk activities including choirs and dancing must not occur; and

Funerals and places of worship are limited to 100 people, subject to the four square metre rule and a COVID-Safe business registration for the venue.

Minister for Customer Service Victor Dominello said inspectors will be regularly on the beat to enforce compliance.

"Any business found blatantly breaking the rules will have the book thrown at them. We won't be listening to any excuses," Mr Dominello said.

"Businesses that aren't serious about safety should not be in business. Those who disregard the restrictions should expect a visit from an inspector.

"We also encourage customers to report wrongdoing. We have a shared responsibility to ensure NSW remains safe."

The NSW Government has made it easy for business by providing industry relevant COVID-Safe plans online.

"Registering your business is simple and can be done online at www.nsw.gov.au," Mr Dominello said.

The rules on gatherings remain the same: 20 guests inside the home and 20 for gatherings in a public place. However, as the home is a high transmission area, the NSW Chief Health Officer strongly recommends a COVID-Safe precautionary approach of limiting visitors to the home to 10 people as a general principle.

UPGRADE TO COUNCIL'S MOWER FLEET

Council recently approved the purchase of a Walker mower as an enhanced replacement for the existing Toro zero turn unit. The new unit was received on Wednesday 15 July 2020 and driven to the RSL Pavilion for Councillors to view during the Ordinary Council Meeting of 22 July 2020.

This new asset will primarily be used for vegetation maintenance at the Tenterfield Cemetery and features a 42 inch cutting deck which will move easily between most monuments in the old section of the Cemetery.

The mower has a rear mounted catcher that has a high dump feature to allow the clippings to be dumped safely into an industrial bin, ute or truck or onto the ground or gardens.

The buttercup yellow mower may also be seen in Bruxner Park, Shirley Park cricket oval or other areas requiring a high quality, clipping free, finish.

The mower is another welcome addition to Council's Parks & Gardens maintenance fleet to assist in ensuring quality workmanship in a safe and efficient manner.

LOCAL HERITAGE PLACES FUND 2020/2021 – APPLICATIONS OPEN

A local Heritage Places Fund has been established by Tenterfield Shire Council with partially matching funds from the NSW Office of Environment and Heritage.

The aim of the fund is to encourage as much positive work on heritage items in the area as possible. The fund will enable applicants to undertake sympathetic repairs to their properties which are consistent with generally accepted heritage principles. Replacing like with like, repainting properties in their original colours, using recycled or traditional materials where possible and undertaking research on the history of a property before undertaking repairs are key ideas which are encouraged by the program.

The Local Heritage Fund funds projects:

- For conservation and maintenance works;
- To meet National Construction Code upgrades (fire, services and access) for ongoing and new uses;

For heritage items and items in conservation areas in the *Tenterfield Local Environmental Plan 2013*.
