#### FINGERLING RELEASE INTO DAM AND TENTERFIELD CREEK

Tenterfield's stock of Yellowbelly were substantially increased on Wednesday, 17 February 2021 with a release of 5,000 fingerlings; 3,000 into various locations along Tenterfield Creek and 2,000 into Tenterfield Dam.

Also known as Golden Perch, the restocking is funded by the Bushfire & Drought Recovery Programme and is part of the NSW DPI Fisheries promise to stock Tenterfield Dam for recreational fishing use in the future.

With the approval of the tender for construction of the new Tenterfield Water Treatment Plant at the December 2020 meeting, Council can now begin to positively plan the use of Tenterfield Dam as a recreational fishing precinct once the new filtration plant is operational in 2022, which gives these tiny fingerlings plenty of time to grow, breed, and establish a good fishing stock.

A large number of breeding trout were also released into the Dam in October 2020 to encourage species recovery following the effects of drought and fire.

"It has been a long road to here", said Mayor Peter Petty.

"In March 2019 Council were awarded \$7 million through the NSW Government's Safe & Secure Water Program to upgrade the Water Treatment Plant. This was supplemented in October 2020 with \$2.64 million from the Federal Government's Building Better Regions Funding."

"Being able to use the Dam for recreational fishing where everybody will have the opportunity to throw in a line will encourage visitors and local alike and I sincerely thank Michael Davey and NSW DPI Fisheries for their assistance in helping Council to access the fish to restock the Dam and Tenterfield Creek", the Mayor concluded.

#### WATER & SEWERAGE ACCOUNTS NOW OVERDUE

Water & Sewerage Notices were due for payment on 1 February 2021. Multiple reminder notices have been issued by post and hand delivered notices will be scheduled for delivery on 8 March 2021 to applicable properties.

If full payment of water & sewerage accounts have not been made or a satisfactory arrangement entered into, Council will install a water flow limiter. Limiter installations are scheduled for Tuesday 23 March 2021. Additional fees will be incurred if a water limiter is installed.



#### RATES & CHARGES THIRD INSTALMENT OVERDUE FOR PAYMENT

Council wishes to advise Residents and Business Owners that the Third Rates Instalment Notices were issued on 27 January 2021. These accounts were due for payment on 28 February 2021.

Ratepayers are reminded that interest is applicable from 1 January 2021 and accrues on all overdue rates and charges and water and sewerage accounts on a daily basis at a rate of 7.0% per annum.

#### THE IMPORTANCE OF RURAL ADDRESS NUMBERS FOR PROPERTIES

Do you have a recognised Rural Address Number issued by Council?

There are many rural properties where property numbers are absent from property entrances and are not visible from the road or cannot be seen at night. This can cause significant delays for emergency services (eg. fire, ambulance, police) and the delivery of goods and services to the rural community.

Rural addressing is a collaborative community project administered by Land and Property Information (LPI, a division of the NSW Government Office of Finance and Services) and local councils, and is supported by all emergency services, Australia Post and other service providers.

Rural addressing numbers are based on a distance from the starting point – usually a road intersection – with odd numbers on the left and even numbers on the right.



To assist rural property owners, Council has available rural address signs for purchase. An application form must be completed and council staff will erect a yellow post with your unique property number at the access to your property.

#### E-WASTE RECYCLING AT TENTERFIELD WASTE TRANSFER STATION

Council has recently changed the company providing e -waste recycling at the Tenterfield Waste Transfer Station (WTS). As a result, Council can offer a wider range of e-waste material that can be recycled. Acceptable materials include:

- Televisions
- Monitors
- Computers, including desktop, laptops and tablets
- Printers
- Scanner
- Fax machines
- DVD's and video players
- Mobile phones and PDA's
- Power tools
- White goods

Council will be accepting these wastes free of charge. They are to be placed in the new e-waste bulk bins provided onsite. You must still see the waste transfer station operator before disposing of any waste, including e-waste.
