THINKING OF RUNNING FOR COUNCIL? REMINDER THAT COUNCIL'S WEBSITE CONTAINS ALL THE INFORMATION YOU NEED

September 2021 Local Government Election Date of Saturday, 4 September 2021 is fast approaching.

All the information you need if you are considering running for election as a Tenterfield Shire Councillor is available for you in one spot – Council's website - https://www.tenterfield.nsw.gov.au/your-council/elections/local-elections

A Councillor's role is important. The decisions a Council makes and the services it provides can change local communities and environments.

Council elections are normally held every 4 years but the current term has run from September 2016 to September 2021 due to the Minister for Local Government passing an amendment to the *Local Government Act 1993* postponing the election from 2020 to 2021 due to the COVID pandemic.

However, the new term from 2021 will still proceed to election in September 2024 making this a 3 year term.

Council has determined that the NSW Electoral Commission will conduct the elections to ensure that protocol, procedure, and transparency is maintained. The Electoral Commission will appoint a Returning Officer who will be the point of contact for all enquiries regarding the election.

The Tenterfield Shire Local Government Area is divided into 5 Wards (A, B, C, D & E) with 2 Councillors elected for each Ward. Council elects the Mayor and Deputy Mayor from amongst the elected Councillors at the first meeting in September. Currently the Mayor holds a 2 year term with the Deputy Mayor being elected annually.

Candidate Nominations

To have your name included on a ballot paper you must be nominated as a candidate for the election and you must be enrolled to vote in the Local Government Area by *6pm on Monday, 26 July 2021*. Nomination period commences *Monday, 26 July 2021* and ends 12 noon, Wednesday, 4 August 2021.

It is envisaged that Council, in collaboration with Local Government NSW, will conduct forums for interested candidates later in the year. Details for these will be widely advertised once arrangements have been finalised.

In the meantime, interested candidates are encouraged to visit the website regularly and

familiarise themselves with all the available information as many legal obligations are involved.

Council's website regarding the elections is updated as new information comes to hand and the NSW Electoral Commission (linked to Council's information) provides regular updates regarding the requirements applying to nominations for individuals or groups.

MAY 2021 - ORDINARY COUNCIL MEETING TORRINGTON HALL

RELEASE OF RAINBOW TROUT INTO TENTERFIELD DAM

Tenterfield's stock of rainbow trout experienced a substantial increase on Friday, 30 April 2021 with the release of a large number of 25-27cm fish into Tenterfield Dam. Some 300 of the fish will be tagged.



The restocking is funded by the purchase of NSW Fishing Licences as well as the Bushfire & Drought Recovery Programme and is part of the NSW DPI Fisheries promise to stock Tenterfield Dam for recreational fishing use in the future.

With the approval of the tender for construction of the new Tenterfield Water Treatment Plant at the December 2020 meeting at a cost of \$8.4 million, Council can now begin to positively plan the use of Tenterfield Dam as a recreational fishing precinct once the new, efficient, filtration plant is operational in 2022, which gives these breeding trout plenty of time to grow, breed, and establish a good fishing stock.

A large number of fingerlings and breeding trout were also released into the Dam in October 2020 and February 2021 to encourage species recovery following the effects of drought and fire.

"It has been a long road to here", said Mayor Peter Petty.

"In March 2019 Council were awarded \$7 million through the NSW Government's Safe & Secure Water Program to upgrade the Water Treatment Plant. This was supplemented in October 2020 with \$2.64 million from the Building Better Regions Funding."

"Being able to use the Dam for recreational fishing where everybody will have the opportunity to throw in a line will encourage visitors and local alike and I sincerely thank Michael Davey and Fisheries Research and Development Corporation (FRDC) for their assistance in helping Council to access the fish to restock the Dam and Tenterfield Creek", the Mayor concluded.
