With more and more products advertised as "flushable" Councils including Tenterfield are seeing the effects downstream costing valuable time and resources to fix.

Those flushable wipes do just that, they flush. But, they don't break down in the sewer system and have the potential to cause blockages of pipes and pumps causing considerable disruption to the sewer network, costing Tenterfield Shire Council a minimum of \$2000 each time a pump needs pulling out for repair.

CONDITIONAL ENTRY TO COUNCIL BUILDINGS

In line with the NSW State Government Public Health (COVID-19 General) Order 2021 of 3 October 2021, Tenterfield Shire Council will be taking reasonable measures to assess people's vaccination status when they are entering Council premises from Monday 11 October 2021.

Council staff will be checking Service NSW QR codes and vaccination status upon entry. Only valid forms of evidence of vaccination will be accepted, being Medicare Certificates of Vaccination in either hard copy (print form) or on mobile devices (phones, tablets or I-pads). Current COVID restrictions apply when entering any Council building, including wearing face masks, social distancing and sign in via the Service NSW App.

KEEPING OUR CEMETERY SAFE

Council wishes to remind all visitors to the Tenterfield Cemetery of some important safety requirements.

A recent audit of the grounds has found a large number of items that are identified as prohibited. Council appreciates the sensitive nature and emotional attachment to many of these items and their relationship to your loved one; unfortunately, as these items pose a risk to council workers, maintenance workers and visitors, to ensure the continued up-keep and maintenance of the Cemetery, all prohibited items will need to be removed.

Council has no option and will soon begin the removal and disposal process of all glass articles. If any of the items are of sentimental value, please remove them immediately. All other items will be removed to a basket located at the new storage shed for collection or later disposal. In particular, the following items pose a risk and are not permitted in the cemetery; glass vases, statues, pot plants, lights, and any other articles other than flowers.

The complete list of prohibited items and activities are listed on the cemetery entrance sign for your information. Thank you for helping to keep the Tenterfield Cemetery safe and orderly for all who visit.

BURNING VEGETATION IN TOWN

Residents wishing to burn vegetation within the town and village limits must obtain a fire permit from Fire & Rescue NSW or Rural Fire Services.

In liaison with the Fire authority Council will inspect prior to any permit being issued. The burning of any vegetation within the town/village limits is generally not supported due to smoke becoming a health concern, hazardous and dangerous to you, your family and to your neighbours.

Vegetation can be disposed of at all Council Waste Transfer Stations.

DEVELOPMENT PROPOSAL - CONCEPT DEVELOPMENT APPLICATION (DA) 2021.132

Tenterfield Shire Council has received an application for the redevelopment of the former Sexton & Green site at 148 Rouse Street, Tenterfield as detailed below.

Stage 1 - Entertainment Facility - Cinema and car parking, including demolition of existing repair workshop, office and hardstand, alterations and additions to main workshop building and landscaping.

Stage 2 - Recreation Facility (indoor) - bowling alley; Health Services Facility - Medical Centre; Centre Based Child Care Facility and Food and Drink Premises

The proposal may be inspected at Council's Offices 247 Rouse Street, Tenterfield, Monday to Friday 9am to 4.30pm and on Council's website www.tenterfield.nsw.gov.au.

Any person may make a written submission to Council about this development application. The closing date for receipt of submissions is Tuesday 2 November at 4.30pm. If the submission includes an objection to the proposal, written grounds of objection must be given. Any submissions received will be considered on their merit in conjunction with the assessment of the application and made available to the applicant for their response prior to assessment.
