VISITOR INFORMATION CENTRE WILL CONTINUE

A more efficient service model for the town's Visitor Information Centre will be investigated by Tenterfield Shire Council (TSC) over coming months.

TSC Mayor Bronwyn Petrie said Council was dealing with major budget pressures and was examining all operations to ensure delivery of sustainable, cost-effective services to ratepayers and visitors to the region.

"Visitor information services will certainly continue, but in a more cost-effective way. We are looking at the model of what's being offered, as well as co-locating from the current standalone site to the Sir Henry Parkes Memorial School of Arts which would provide building and maintenance savings.

"The Information Centre and its staff have done a great job and Council will continue to support visitors with information and guidance on the region's many historic and natural attractions.

"We'll be consulting with the community and businesses on the best way to meet the needs of visitors to our region," Cr Petrie said.

Broader review of Council services

Cr Petrie said assessment of the Visitor Information Centre

operations was part of Council's broader review of services to contain operating costs and redress budget deficits.

"With the new Council's term (two-and-a-half years) shorter than the usual four years, we need to make decisions to ensure our operations and services are efficient and financially viable.

"I'll be working with fellow Councillors to ensure our community is kept fully-informed of all proposed changes, including with rates and the Visitors Information Centre," Cr Petrie said.

SPECIAL DISASTER GRANTS – NSW SEVERE WEATHER & FLOODING FEBRUARY 2022 ONWARDS

The NSW and Australian Governments have announced additional assistance measures to support primary producers who have been impacted by the floods and severe weather that occurred from February 2022 onwards.

Assistance is now being provided to 45 Local Government areas in NSW through the jointly funded Commonwealth-State Disaster Recovery Funding Arrangements (DRFA). Primary producers recovering from the devastating impacts of floods are receiving vital support, with **Special Disaster Grants of up to \$75,000 now available**.

Flood affected primary producers are encouraged to apply for Special Disaster Grants to access financial assistance to get back operating as soon as possible. Once approved, eligible primary producers can access \$15,000 in assistance up-front, with a further \$60,000 in financial assistance available thereafter upon submission of valid tax invoices.
