## AUSTRALIAN LOCAL GOVERNMENT ASSOCIATION CONFERENCE WRAP-UP

Recently the Mayor, Cr Bronwyn Petrie and Chief Executive, Daryl Buckingham attended the Australian Local Government Association Conference in Canberra, ACT. This is the national voice of local government, representing 537 councils across the country.

Tenterfield Shire Council proposed three recommendations for consideration by the Council's represented, and all three recommendations were passed without dissent. The third recommendation was absorbed into another recommendation by other councils as it reflected a general consensus of several councils.

The two individual resolutions are as follows:-

This National General Assembly calls on the Australian Government to provide grant funding in advance to regional land rural councils and not in arrears so as to avoid impacting unfavourably on said council's cash flow - Motion carried.

This National General Assembly calls on the Australian Government to allow councils to use new grant funding opportunities for projects already contained within their operational plan that would have otherwise been funded from loans (currently they are excluded) - Motion carried.

Councillors and Senior staff were eager to host the LGNSW Chief Executive, Mr Scott Phillips and President, Cr Darriea Turley AM on Tuesday 12 July 2022 for a briefing and consultation of Local Government lobbying and issues.

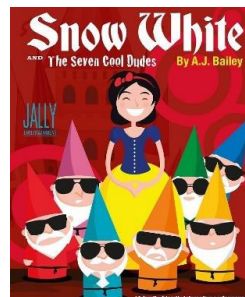

### I receive my Rates Notice Electronically, where are my Waste Vouchers?

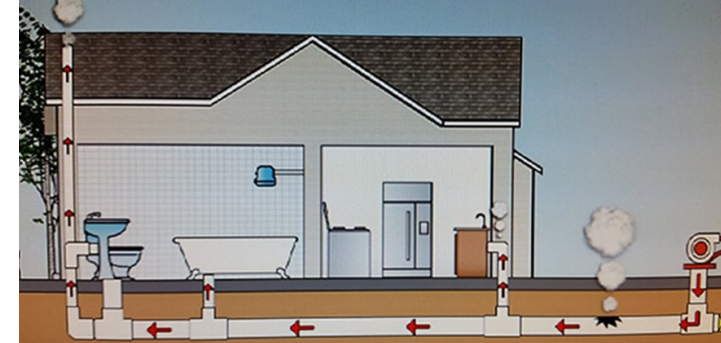
All waste vouchers are hard copies and sent by post.

Council has allocated three (3) waste vouchers per rate assessment for this financial year (1 July 2022 to 31 July 2023). Vouchers will not be replaced if lost or destroyed. Regular audits of redeemed vouchers are performed and in the event excess vouchers have been used for a single assessment an invoice will be issued.

Rates have been increased in line with the rate peg of 0.7% as determined by the Independent Pricing and Regulatory Tribunal (IPART).

The Office of Local Government has set the interest rate payable on overdue rates and charges and water & sewerage consumption accounts for the 2022/2023 at 6% p.a.

## SMOKE TESTING FOR TENTERFIELD SEWER NETWORK—COMMENCING 8 AUGUST 2022

As stated in Your Local News Issue 163, Tenterfield Shire Council has engaged a contractor to undertake smoke testing throughout the Tenterfield sewer network. Due to flooding down South affecting the contractors work schedule, these works will now commence on Monday 8th August 2022.

The aim of this process is to establish where stormwater is infiltrating our sewer system putting increased demand on the Sewerage Treatment Plant during rain events

To check for entry of stormwater into the sewers, contractors will "smoke bomb" the sewer system by forcing smoke up the Council sewer pipes and into house drainage pipes.

The smoke is non-toxic, non-staining and has no odour, is white to grey in colour and does not create a fire hazard. The smoke should not enter your home/business unless you have defective plumbing or dried up drain traps. Smoke coming from broken pipes, grates or downpipes may indicate that stormwater enters the sewer from your property and/or sewer gases may also be entering your home or business.
