(ITEM GOV101/22) APPLICATION TO IPART FOR A SPECIAL RATE VARIATION TO INCREASE GENERAL INCOME - ORDINARY RATE INCOME. SUMMARY

This report is in response to Council resolution (237/22) and is the proposed Final Draft Application to IPART Independent Pricing and Regulatory Tribunal) for a Section 508 A (Permanent) Special Rate Variation (SRV) for the Financial Year commencing 2023/2024 and 2024/2025.

This application developed for submission is consistent with Council resolution (237/22)- Notification to IPART of Intent to Apply for a Special Rate variation comprising a permanent Special Rate Variation of 43% (including rate peg) in 2023/2024 and 43% (including rate peg) in 2024/2025, representing a cumulative increase of 104.49%.

 Receive the attached application for a permanent Special Rate Variation.

SUMMARY

The purpose of this report is to advise Council that staff have advertised for Expressions of Interest for the conduct of the 2024 Local Government elections as per Council's Resolution #231/22.

Council is required to advise the Electoral Commission of NSW (ECNSW) whether it requires them (ECNSW) to conduct the upcoming Local Government Elections in September 2024 by 13 March 2023.

No suitably, qualified, or experienced individuals / businesses have been forthcoming, therefore Council is required to resolve to appoint the NSW Electoral Commission of its intent to proceed with the conduct of the 2024 Local Government Elections/By-elections for Tenterfield Shire.

OFFICER'S RECOMMENDATION:

That Council:

- (1) Note that Council did not receive any suitably qualified Contractor/s to conduct the September 2024 Local Government Elections from its advertising: and
- (2) The Tenterfield Shire Council ("the Council") resolves:
 - a) Pursuant to s. 296(2) and (3) of the Local Government Act 1993 (NSW) ("the Act") that an election arrangement be entered into by contract for the Electoral Commissioner to administer all elections of the Council.

BACKGROUND

As per Council's Resolution of the Ordinary Council Meeting held Wednesday 26 October 2022 - # 231/22

Resolved that Council:

(1) Advertise for quotations from a suitably qualified Contractor to conduct the September 2024 Local Government Elections; and

(2) If no suitably qualified Contractor be forthcoming; Council advises the NSW Electoral Commission (ECNSW) of its intent to proceed with NSWEC conducting the 2024 Local Government Election.

Staff subsequently advertised locally, for Expressions of Interest for the conduct of the full Local Government Election/By-elections for September 2024.

No suitably qualified individuals/organisations sought any additional information or provided information as per the advertisement. (Attached)

Council therefore needs to provide written acknowledgement to the Electoral Commission NSW as per the LG NSW Circular 22-35 Dated 11 November 2022/A839620, which was received after Council's previous resolution. This Circular (Attached) provides specific wording for Council's to use as their Resolution.

As previously advised, Council must pass the appropriate resolution no later than 18 months before the next ordinary elections, should they require the NSW Electoral Commission to conduct their elections. That means that the resolutions for the September 2024 elections must be passed by 13 March 2023.

Council, due to austerity measures and current staff numbers, does not currently have the resources available to accommodate the 2024 Local Government election. This report recommends now that the NSW Electoral Commission is the most suitably positioned and qualified organisation to conduct the 2024 Local Government Election/By-Elections.

REPORT:

In the past Council has entered into an Agreement with the ECNSW, which included a Scope of Works outlining certain items required by both the Council and ECNSW. The last Agreement for the 2021 Local Government elections outlined specific tasks, expectations and estimates of costings. The quotation received from ECNSW totaled \$83,000.

During the 2021 elections there was a lack of candidates for each Ward, with some Wards not requiring an election to be held as they had two nominations only.

Staff subsequently advertised locally, for Expressions of Interest for the conduct of the full Local Government Election/By-elections for September 2024.

No suitably qualified individuals/organisations sought any additional information or provided information as per the advertisement.

Council does not currently have the resources to conduct the 2024 Local Government election. As advertising for suitably skilled contractors to quote on conducting the election found no suitably qualified individuals/organisation to undertake the 2024 Local Government Election/s then Council needs to contract with the Electoral Commission.

Councils' decisions on the administration of their September 2024 ordinary elections

What's new or changing

- Under section 296AA of the *Local Government Act 1993* (the Act), councils are required to make a decision on how their ordinary elections in September 2024 are to be administered by **13 March 2023**.
- Each council must resolve either:
 - to enter into an election arrangement with the NSW Electoral Commissioner (NSWEC) to administer all the council's elections, polls and constitutional referenda or
 - that the council's elections are to be administered by another electoral services provider engaged by the council.
- If a council does not resolve to engage the NSWEC to administer its elections by 13 March 2023, it must engage another electoral services provider to do so.

What this will mean for your council

- Councils are required to make a decision under section 296AA by 13 March 2023 on the administration of their next ordinary election. Information to assist councils in making that decision is provided in the attached FAQ.
- If a council is proposing to engage the NSWEC to administer its elections, it should resolve to do so as soon as possible and notify the NSWEC.

Key points

- Where councils resolve to engage the NSWEC to administer their elections, polls and referenda, a model resolution is suggested in the attached FAQ.
- If a council resolves to adopt an electoral services provider other than the NSWEC, the resolution must state whether the general manager has identified an electoral services provider to be engaged for the next ordinary election and, if so, the name of that provider.
