OLD POWERHOUSE RESERVE PLAN OF MANAGEMENT CROWN RESERVE R22044

Council resolved at the Ordinary Council Meeting of 28 September 2022 that the Plan of Management Old Powerhouse Reserve – Crown Reserve R22044 be endorsed and forwarded to the Crown Lands Minister for approval. Crown Lands have endorsed the Plan of Management and it will be placed on public exhibition and submission invited.

This Plan of Management will be on exhibition for a period of 28 days, being from Thursday, 22 December 2022 to 5.00pm Wednesday, 18 January 2023. Submissions will be accepted by Council until 5.00pm Wednesday, 1 February 2023.

Should no submissions be received on this Plan of Management, it will be considered adopted by Council under clause 70B of the Crown Land Management Regulation 2018.
