Welcome to the Killarney P-10 State School P&C Border Ranges Trail Ride!

## TRACK RULES:

- DO NOT CALL 000 when riding on the tracks. We have the Queensland Ambulance Service and other health providers on the tracks all weekend. If you are unable to find a sweep rider, call the emergency number given to you at nominations.
- Please install Emergency+ App on your smartphone as this will give you GPS co-ordinates in case of emergency.
- Bikes and riding gear must be clean before entering the track. Please no tear-offs and do not litter.
- Participants will undergo random alcohol and drug testing.
- Riders under 18 must be accompanied by a parent, guardian or responsible adult at all times while riding the open track.
- Due to road closure provisions, riders are not permitted to participate in this event if they currently have a drivers licence that has been suspended, cancelled or disqualified.
- Spectators are not permitted on the tracks.
- No quad bikes allowed.
- The peewee track is available for bikes up to 110cc. No motocross bikes on peewee.
- Do not ride unregistered bikes on the roads.
- Protective clothing, helmets and boots must be worn at all times whilst riding.
- Please ensure you have your own water bottle.
- QAS have requested that all riders wear underwear.
- Safe and considerate riding is expected from all riders. You may be asked to leave.
- Riding is only permitted on the marked tracks during the times the tracks are open. There is no warm-up or testing - this is not a competition!
- No smoking or littering on the ride.
- Riders must have full tank of fuel for Saturday and Sunday loops.
- All riders must read the RIDER'S BRIEFING
- Fuel needs to be at the truck by 8am for the Saturday loop. Please have your containers clearly marked with your name and rider number.

## CAMP RULES:

- RIDING AROUND THE CAMPSITE IS PROHIBITED. You may be asked to leave.
- Your machine is a valuable investment. Please ensure that your bike and equipment are securely stored at all times.
- Fires are prohibited. This includes fire drums, braziers and other heating or cooking device that has coals or charcoal. Gas BBQs are permitted.
- Liquor is permitted within your own campsite area, but must not be removed from that area.
- NO GLASS objects or bottles are permitted on the grounds.
- Noise curfew on bikes - between 6pm and 7.30am
- Camp noise curfew - between 10.30pm and 7am
- Killarney Showgrounds is the designated quiet family friendly camping area.
- If you are camped near the oval at the Recreation Grounds we ask that you ensure that your belongings are well secured as you camp site may be affected by the downdraft of the rescue chopper if they need to land.
- Dogs are prohibited.
- Please use the plastic bag provided for your rubbish and place it into the skips situated throughout the camp or take it home with you.

## GENERAL EVENT RULES:

- Proof of age identification is required for purchasing alcohol.

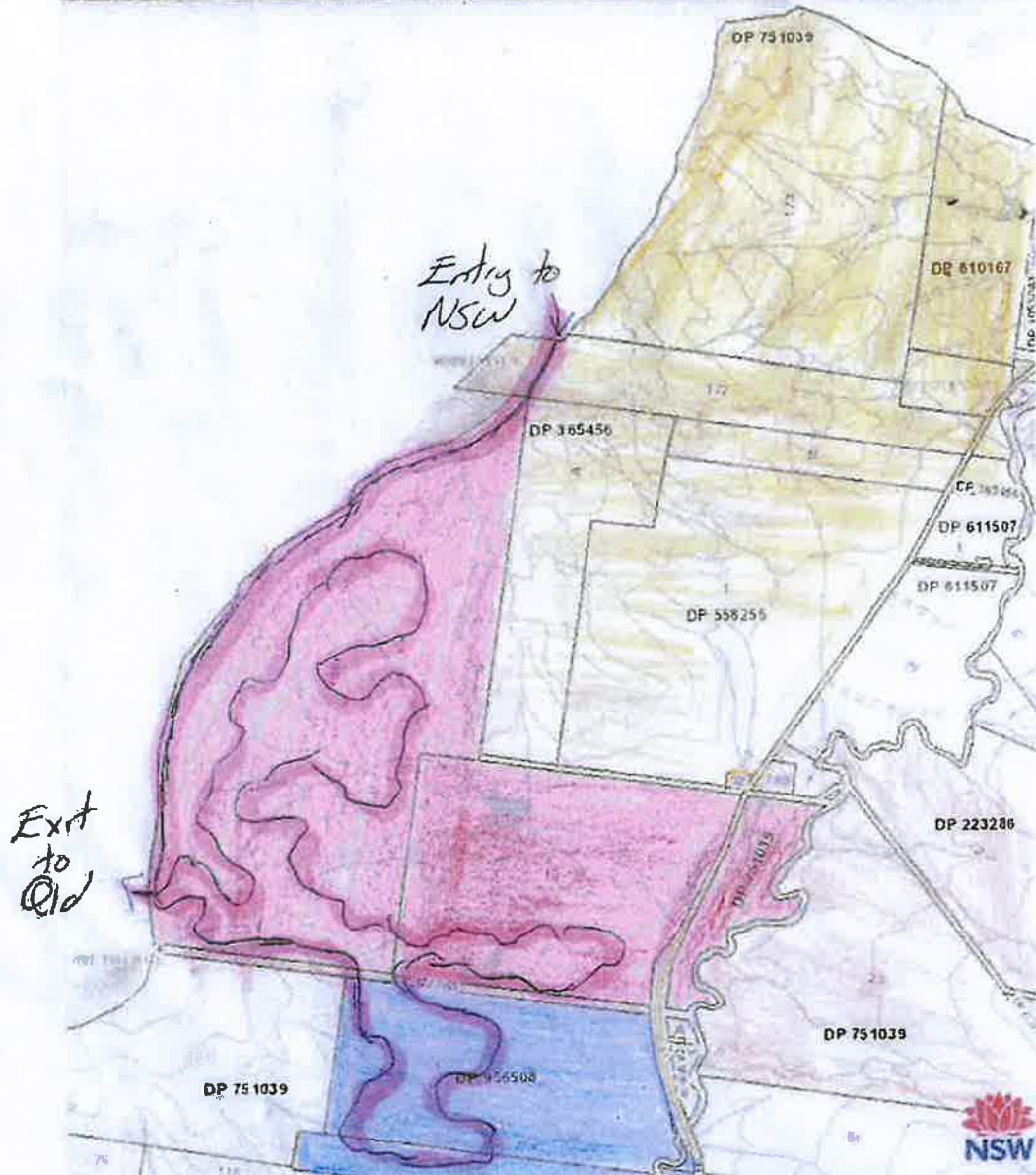
